

2024-2025 UNIFORM POLICY

FCA aims to lead its students to appreciate the various practices, arrangements, standards, and etiquettes that make up the life of FCA collectively and reveal FCA as a place set apart from the world as a lived-out expression of a unified people in, but not of, the world.

School uniforms demonstrate a common telos, that is, a common purpose or goal. This is the case with all uniforms – whether in sports or military or the clergy – all uniforms embody a shared identity, a shared purpose, and thus FCA students are encouraged to exercise their individual gifts for the benefit of the whole community to the glory of God. The FCA uniform identifies students as being part of a community which upholds FCA’s beliefs and signifies a united commitment to each other and the school.

| <ul style="list-style-type: none"> FCA’s Land’s End school purchase number is 900150798. It’s Sew Altering is the locally approved vendor for FCA-logoed items if not logoed by Land’s End. All logoed items must have the current, official FCA logo. All jumpers, skirts, and shorts, whether uniform or spirit wear must be worn within 2” of the top of the knee except for shorts worn under jumpers and skirts. Specified clothing that can be purchased from other vendors must match in color, cut, and style to those on FCA’s Land’s End page. All clothing should be worn as intended (e.g., tucked in, not rolled at the waist or the ankle and not tucked into boots, girls’ clothing worn by girls only), should be neat, clean, and appropriately sized (e.g., not tight-fitting, baggy, low-cut), and should be clearly marked with child’s name or initials. White, black, or navy undershirts may be worn but should not extend beyond the sleeve or cuff of the uniform shirt. PE shorts and t-shirts are only necessary for fourth and fifth grade and are provided through the academic fee. PE uniforms should be washed regularly. House t-shirts are provided for secondary students (6th-12th grade) through the academic fee. Socks must match each other. Tights, leggings, and cartwheel-style shorts are only to be worn under skirts and jumpers. Only non-marking shoes are to be worn when on the gym floor (e.g., not a wedged heel or a cowboy boot). Students are not to wear wedged heels or cowboy boots. | | |
| Spirit Wear | <ul style="list-style-type: none"> All students may wear spirit wear on designated all-school spirit days. Secondary students may wear House attire or other spirit wear. Uniform pants, jeans without holes or tears, athletic-style sweatpants (not legging-style), or skirts and shorts (worn within 2” of the top of the knee) are permitted. Upper body wear must have sleeves and may be untucked. Student-athletes or performers may wear their FCA warm-ups, jackets, or other spirit wear associated with their sport or discipline. Low-cut or midriff-exposing tops are not permitted. Shoes must comply with uniform specifications. | |
